Enclosed please find a case sheet established for Professor Luiz Basilio Rossi, a professor of Economics at the Faculty of Philosophy, Sciences and Letters at the university of Penapolis in Sao Paulo, Brazil, who was arrested on the 15th February at his home and since when he has been held incommunicado.

We hope that you view the circumstances of this arrest in as serious a light as we do, and that you will support us in our campaign on his behalf, If this is the case we would ask you to write or telegraph immediately to the following addresses, expressing your concern at the arrest and disappearance of the professor, and urging that the writ of habeus corpus be granted and Professor Rosi be allowed to communicate with his lawyer and family:

The sources of our information on this case comes from a cutting in the Brazilian newspaper, O Estado de Sao Paulo of the 2nd March 197 in addition to private sources in Brazil itself.

Professor Rossi was arrested on the 15th February at 7.30 in the evening at his home along with another man who was visiting him at the time. His home was surrounded by a combined action of the military police armed with machine

guns, acting with members of the local police, the army police and the political police (DOFS) of Sao Paulo. The combined units forced their way into the house, searched it bhoroughly, and removed a number of books from the library and some documents dealing with political resistance movements in Brazil. Rossi, along with his visitor, was arrested.

The two were taken from the house at Aracatuba at one o'clock in the morning to Lins, headquarters of the army corps in that region. Rossi's wife and children were kept under surveillance at their home until Saturday, February 17th. On the afternoon of the 17th, Mgr. Koop, the bishop of Lins, went with Senhora Rossi to the army headquarters at Lins in an attempt to gain information. The officer with whom they spoke would only say that Rossi was being held by the army at Lins.

On the 19th, Rossi's wife was told that she might as well return home as her husband was no longer being held at Lins. The person who gave her this information was unwilling to tell her where her husband had been taken but one of the soldiers did say that the professor, the man who had been arrested with him, and a young girl (apparently arrested separately from Rossi — but this is not completely clear) had been taken to Sao Paulo that morning.

Since then, despite a letter from the bishop of Lins to the judge of the 2a Auditoria Militar (judicial court) in Sao Paulo, who is responsible in that area for dealing with crimes against the 'national security', nothing has been learned about the whereabouts of Professor Rossi.

Rossi's lawyer, Virgilio Enei, has presented a writ of habeus corpus on his behalf, based on article 153, paragraph 2 of the Federal Constitution and article 466 and subsequent provisions of the Military Penal Code. In his petition to the Superior Military Tribunal for habeus corpus, Enei states that he has not been able to obtain any information concerning his client from the authorities. He requests information from the commanders of the Second Army and the 4th Aeronautical Zone, as well as from DOPS, and calls for the lifting of the state of incommunicado in which his client is being held.

Brazil's Law of National Security, which defines offenses against the national security, and sets the penalties for convictions, has no article specifically covering the possession of banned literature. Nevertheless, it is normally considered prima facie evidence of membership in an illegal organisation and is often the only evidence produced in court. Furthermore, the degree of vigilance which Brazilian authorities have exercised over political groupings and information dissemination since the 1964 coup which brought the present government to power makes it impossible to conclude that the papers found necessarily concerned 'subversion'. Thus we are making this case an adoption action, and you will find enclosed several stencilled lists of instructions for action and of addresses to contact with regard to this case.

2. Write on plain paper to the bishop of Lins, stating your concern at reading of this case in O Estado de Sao Paulo of 2nd March 1973 and ask whether the family is in need of assistance. Ask how best to contact them to send such assistance, if required, and ask for information about the man, and possibly a young girl, arrested with Rossi. DO NOT MENTION AMMESTY INTERNATIONAL and DO NOT CONTACT THE FAMILY UNLESS the bishop of Lins agrees that it is safe to do so.

3. Write on plain paper to Professor Jose Oscar Beozzo at the Faculty of Philosophy in Penapolis, naying that you have read of this case in O Estado de Sao Paulo and would be grateful if he would keep you in touch with further developments on the case. DO NOT UNDER ANY CIRCUMSTANCES MENTION AMNESTY INTERNATIONAL AND DO NOT MENTION BEOZZO'S NAME IN ANY COPRESPONDENCE OR PUBLICITY. Again, ask about the man and girl involved.

- 4. Work quickly to organise petitions and letters of concern on behalf of Professor Rossi. Students and professors in faculties of philosophy, sciences and letters should be particularly concerned.
- 5. When writing to the lawyer don't forget to ask for information about the man, and possibly the girl, arrested with Rossi.
- 6. Write to the following people asking for information about the present state of Professor Rosal's case:

Write on Amnesty paper, citing as source of information, the O Estado article and expressing concern about Professor Rossi's fate.

ACT QUICKLY: thme may be crucial in locating Professor Rosel, or even in helping to save his life. Others have disappeared in this manner and never been kound again, alloyedly dead under tecture. Professor Rosel in even now apparently at the stage of interrogation, before charges are even filled, and it is at this stage in police investigations that it is feared tecture often takes place. We must do all we can to guard against such a possibility.

Attachments: We have sent you a photocopy of a letter which came to us from Beozzo with information on this case, but have blocked out his name. Again, under no circumstances use Amnesty notepaper or mention Amnesty in writing to Beozzo, and do not mention his name as your source of information. Dearing this precaution in mind you might still be able to use his letter in interesting the press in carrying publicity on the case.
