There has been growing social unrest in Venezuela in the months since April 2017. There have been hundreds of protests which the state's responded with disproportionate use of force against both those who took part in protests and others who did not. Members of the Venezuelan security forces have carried out raids in residential areas and misused force against demonstrators, in serious injury and death.

Amnesty International's analysis of information published by the Venezuelan Attorney General indicates that at the time of writing (6 June 2017), 92 people died as a result.


The deaths were not confined to one the country; they occurred in the states of Miranda, Táchira, Mérida, Carabobo, Barinas, Lara, Zulia, Bolívar, Trujillo, Anzoátegui, Trujillo, Vargas, and Sucre and in the capital city, Caracas.

Of these 92 deaths, 70% were the result of the use of firearms by law enforcement officials and armed groups of civilians; 68% of those killed were aged between 20 and 35.

The Venezuelan state must put an end to the unlawful use of force against the Venezuelan population and enable people to exercise their right to peaceful protest. It must also investigate serious human rights violations committed by officials and by civilian armed groups and ensure full reparation for the victims.




Cases of injuries under investigation by district attorneys dealing with Family Protection

1 Jairo Johan Ortiz Bustamante

+ 6 April 2017 Miranda

A 19 year old student at the Caracas National Experimental University of Caracas (Universidad Nacional Experimental Politécnica de Caracas).

He was **shot**, during a demonstration in Carrizal, Miranda state, and died of his injuries on 6 April 2017. Rohenluis Leonel Rojas Mara, an officer with the Bolivarian National Police, is currently detained charged with homicide and unauthorized use.

The 39th National Attorney and 24th State Attorney of Miranda were commissioned to investigate this case.

2 Daniel Alejandro Queliz Araca

+ 10 April 2017 C a r a b o b o

A 20 year old law student at atthe Arturo Michelena University (Universidad Arturo Michelena) in San Diego, Carabobo state, and an only child. He played baseball, and hoped to becomea professional player.

He on 10 April 2017, after being shot the neck during a demonstration in Los Parques, Miguel Peña Parish in the Valencia Municipality of Carabobo State. Two members of the Carabobo State Police Marcos Ojeda and Edwin Romero have beendetainedcharged with homicide and unauthorized use of a service weapon.

The 39^{th} National Attorney and 24^{th} State Attorney of Miranda were commissioned to investigate this case.

3 Miguel Ángel Colmenarez Milano

+ 11 April 2017

A 36 year old sales assistant who worked in a family business selling car filters.

He died on 11 April 2017. He was watching the demonstration in 59th Street in Barrio Nuevo, Barquisimeto, Lara State, when he was accosted by several men. They took his belongings, threw stun grenades (known as aturdidoras) at him and then shot him with a shotgun.

Lara

The 44th National Attorney and 6th State Attorney of Lara were commissioned to investigate this case.











4 Brayan David Principal Giménez

+ 11 April 2017

A 14 year old high school student.

On 11 April 2017, he was in Alí Primera, El Cují Parish, Lara state, when he was shot with a firearm resulting in internal bleeding and extensive damage toblood vessels. The shots were firedfrom a vehicle. One suspected, Héctor Zapata Felice, has been charged in connection with the case with the crimes of complicity in aggravated homicideand grievous bodily harm.

Lara

The 79th National Attorney and 20th and 16th State Attorneys of Lara were commissioned to investigate this case.

5 Gruseny Antonio Canelón Scirpatempo

+ 13 April 2017

A 32 years old athlete who sold car parts, he was known as Tony to his friends and family.

On 11 April 2017, he was fatally wounded when he was hit byseveral bullets fired from a fire arm as he was walking around a demonstration taking place in Bellas Artes de Cabudare, Lara state. He was transferred to the Central Antonio María Pineda Hospital in Barquisimeto, where he died on 13 April.

Lara

The 85th National Attorney and 21st State Attorney of Lara were commissioned to investigate this case; 14 arrest orders were issued against Bolivarian National Guard officers.

6 Carlos José Moreno Barón

+ 19 April 2017 Caracas

A 17 year old student Central University of Venezuela (Universidad Central de Venezuela). He lived with his mother and sister and used to play soccer in his free time.

He died on 19 April 2017, after being hit in the head by a bullet during a demonstration in La Estrella Square, San Bernardino, Capital District. He and another adult were hit when a group of motorcycle riders threw tear gas grenades and fire into the air several times. He was aken to the Caracas Clinic Hospital where he died.

Two people were detained in connection with his death, one of whom was an officer with the Sucre Municipal Police. The 79th National Attorney was commissioned to investigate this case.











7 Niumar José Sanclemente Barrios

+ 19 April 2017

He was 28 year old, second sergeant in the Bolivarian National Guard who was promoted to first sergeant posthumously for his work.

Miranda

He was father of a 6 month old girl. On 19 April 2017, he was on duty policing a demonstration on the first flyover of the in San Antonio de Los Altos perimeter road in Los Salias Municipality, Miranda state, when an unidentified person shot at the National Guard officers, several times, injuring him Niumar José Sanclemente Barrios his partner Juan Carlos Arias Méndez. Both were taken to Central Médico Docente el Paso Clinic, where he died.

The 24th National Attorney and 1st State Attorney of Miranda were commissioned to investigate this case.

8 Paola Andreína Ramírez Gómez

+ 19 April 2017

A 23 year old was student at Catholic University of San Cristobal in English (Universidad Católica San Cristóbal)

Táchira

On 19 April 2017, she was in Las Palomas Square in the San Carlos neighbourhood, Táchira state, when she was stopped by several people who tried to take her belongings. When she tried to run away, she was shot at and a bullet pierced her lungs.

The homicide, assailant, who had already been charged by the Attorney General fired the, shot from the rooftop of his house.

The 4th State Attorney of Táchira was commissioned to investigate this case.

9 Elio Manuel Pacheco Pérez

+ 20 April 2017

He was 21 year old a worker at Fospuca a Caracas cleaning service company. He was student of Administration Studies.

Caracas

He died on 20 April 2017, after receiving anelectric shock as he several others were going into the "La Mayer del Pan," bakery in San Andrés, Cajigal Street, El Valle. He suffered cardiogenic shock as a result.

The 40th and 121st District Attorneys of the Metropolitan Area of Caracas were commissioned to investigate this case.













10 Jairo Ramírez

+ 20 April 2017 Caracas

A 46 year old a car mechanic working for the Supra Caracas company. He lived with his wife and four children.

He died after receiving an electric shock on 20 April 2017 at the "La Mayer del Pan," bakery in San Andrés, Cajigal Street, El Valle.

The 40th and 121st District Attorneys of the Metropolitan Area of Caracas were commissioned to investigate this case.

11 Robert Joel Centeno Briceño

+ 20 April 2017

A 29 year-old, father of three, who worked as warehouseman in Suvinca and played soccer for the Coche team.

Caracas

He died after receiving an electric shock on 20 April 2017, at the "La Mayer del Pan" bakery in San Andrés, Cajigal Street, El Valle.

The 40th and 121st District Attorneys of the Metropolitan Area of Caracas were commissioned to investigate this case.

12 William Heriberto Marrero Rebolledo

+ 20 April 2017

A 33 year old stylist, living in San Andrés sector in El Valle, lived with his mother, aunt and grandmother.

He died after receiving an electric shock on 20 April 2017, at the "La Mayer del Pan" bakery in San Andrés, Cajigal Street, El Valle.

The 40th and 121st District Attorneys of the Metropolitan Area of Caracas were commissioned to investigate this case.













13 Jonathan Antonio Menezez López

+ 20 April 2017

A 27 year old self-employed bricklayer liveding with his family in El Valle. He was father of two children.

He died after receiving an electric shock on 20 April 2017, at the "La Mayer del Pan" bakery in San Andrés, Cajigal Street, El Valle.

The 40th and 121st District Attorneys of the Metropolitan Area of Caracas were commissioned to investigate this case.

14 Romer Stivenson Zamora

+ 20 April 2017 Caracas

A 29 year old motorcycle taxi rider in El Cajigal, and trade unionist in the construction industry. He used to play basketball in his community and had a one year old daughter.

He died after receiving an electric shock on 20 April 2017, at the "La Mayer del Pan" bakery in San Andrés, Cajigal Street, El Valle.

The 40th and 121st District Attorneys of the Metropolitan Area of Caracas were commissioned to investigate this case.

15 Kenyer Alexander Aranguren Pérez

+ 20 April 2017

A 20 year old who worked as freelancer in different areas. He lived with his mother, siblings and grandmother in San Andrés, El Valle.

Caracas

He died after receiving an electric shock on 20 April 2017, at the "La Mayer del Pan" bakery in San Andrés, Cajigal Street, El Valle.

The 40th and 121st District Attorneys of the Metropolitan Area of Caracas were commissioned to investigate this case.















16 Yorgeiber Barrena Bolívar

+ 20 April 2017 Caracas

A 15 year old sophomore student at Fray Pedro De Agreda High School. He used to play sports in the community of El Valle. He lived in the Zamora neighbourhood with his father.

He was at home and went with his uncle o the place where violent clashes were taking place. He died after receiving an electric shock on 20 April 2017, at the "La Mayer del Pan" bakery in San Andrés, Cajigal Street, El Valle.

The 40th and 121st District Attorneys of the Metropolitan Area of Caracas were commissioned to investigate this case.

17 Albert Alejandro Rodríguez Aponte

+ 20 April 2017

A 16-year-old high school student at Liceo José Avalos. He suffered from heart disease, and so led a quiet life-style. He lived with his mother.

Caracas

He died on 20 April 2017 in San Andrés street, El Valle. He had left the house with his uncle and when they got to the ground floor inhaled tear gas, which led to breathing problems and a heart attack. He was immediately taken to the Mother and Child Hospital in El Valle, where he died.

The 79th National Attorney and 98th District Attorney of the Metropolitan Area of Caracas were commissioned to investigate this case.

18 Ramón Ernesto Martínez Cegarra

+ 20 April 2017

A 28 year old shopkeeper who worked selling empanadas and fruit juices in his own shop. He had three children.

Caracas

On the day of his death, he was home, but when he learned that lootingwas taking place in El Valle, he went to check his shop. There was an exchange of words with some people he was shot dead.

The 40th and 121st District Attorneys of the Metropolitan Area of Caracas were commissioned to investigate this case.

+ 20 April 2017

A 34-year-old bricklayer's assistant. He had a two-year-old daughter.

He was shot during a demonstration in Cajigal Street in El Valle and later transferred to the University Hospital Clinic; he was dead on arrival.

The 40th and 121st District Attorneys of the Metropolitan Area of Caracas were commissioned to investigate this case.

20 Kevin Steveen León Garzón

+ 20 April 2017 Caracas

He was 19 years old and lived with his mother and sister. He worked as freelancer doing various kinds of work.

On 20 April 2017, he was taking part in in front of Juan Manuel Cajigal building in Intercomunal Avenue in El Valle, when he was shot; the bullet fractured his skull.

The 40th and 121st District Attorneys of the Metropolitan Area of Caracas were commissioned to investigate this case.

21 Mervins Fernando Guitian Díaz

+ 20 April 2017

He was 25 years old and he worked as supervisor in the public maintenance section of Sucre Municipality City Hall. He suffered from epilepsy.

Caracas

On 20 April 2017, he was shot in the abdominal area while walking in 5 de Julio neighbourhood of Petare, where a demonstration was taking place.

The 80th and 125th District Attorneys of the Metropolitan Area of Caracas were commissioned to investigate this case.













22 Almelina Carrillo Virgüez

+ 25 April 2017 Caracas

A 48-year-old waitress, she had worked at the La Arboleda Clinic in San Bernardino since 1999, and she lived with her parents and son. She was the family's main breadwinner.

On 19 April 2017, she was walking by La Esmeralda corner, La Candelaria Parish, on her way to work when a bottle of frozen liquid that had been thrown hit her in the head causing severe trauma. She was taken to La Arboleda Clinic, where she died four days later.

The 38th and 121st District Attorneys of the Metropolitan Area of Caracas were commissioned to investigate this case, and Jesús Juan Albi Zambito Zambitohas been prosecuted in connection with her death.

23 Jesús Leonardo Sulbarán

+ 24 April 2017 Mérida

A 41-year-old criminologist and father of a one year-old girl, he worked in the Merida State's People's Power State Ministry for Comprehensive Policies.

On 24 April 2017, he was in Las Américas Avenue at the junction with Viaducto Campo Elías, Merida State, when he was shot in the neck and back of the chest, causing extensive internal bleeding.

The 38th National Attorney and 4th State Attorney of Merida were commissioned to investigate this case.

24 Luis Alberto Márquez

+ Mérida 24 April 2017

A 52-year-old father o three who worked as a gardener in the Faculty of Science of Los Andes University (Universidad de Los Andes).

The 38th National Attorney and 4th State Attorney of Merida were commissioned to investigate this case.

Eight arrest warrants were issued in this case and three people weredetained at the time of writing.

+ 25 April 2017

He was 22 years old and lived with his mother and his one year old son. He worked as a janitor in the Liceo Seferino Castillo del Tocuyo, Lara state.

On 25 April 2017, he was on a demonstration in Lisandro Alvarado Avenue, when he was shot, causing trauma to the head.

The 44th National Attorney and 6th State Attorney of Lara were commissioned to investigate this case.

27 Christian Humberto Ochoa Soriano

+25 April 2017

A 22 year-old student of electrical studies.

On 25 April 2017, he was in the Romulo Gallegos Alley in the Francisco de Miranda neighbourhood Valencia, Carabobo state, while a protest was being held near by. He was hit by live ammunitionfired by Carabobo state police officers. He was taken to Valencia Central Hospital where he died of injuries; he had sustained several bullet wounds in the upper right abdomen.

Carabobo

The 34th National Attorney and 35th State Attorney of Carabobo were commissioned to investigate this case; a regional police officer was charged in connection with the case.

A 21-year-old assistant motor mechanic.

He was taken to Valencia Central Hospital, but was dead on arrival.

26 April 2017 + Lara

He was 20 years old and had an eight-month-old child. He was the second of six brothers and worked as cellphone technician.

On 26 April 2017, he was on a demonstration in Concepción Parish in Barquisimeto, Lara state, where he was shot in the left side of the head by unidentified people.

The 21st State Attorney of Lara was commissioned to investigate this case, and requested that arrest warrants be issued against four officers of the Bolivarian National Guard.

28 Juan Pablo Pernalete Llovera

+ 26 April 2017 Caracas

He was a 20-year-old student of public accountancy at the Metropolitan University (Universidad Metropolitana). He was part of the university basketball team and had a sports scholarship. He lived with his parents, sister and grandmother.

On 26 April 2017, he was in a demonstration in Altamira where was injured. He was immediately transferred to a medical center in the Chacao municipality, Miranda state; he was dead on arrivaland had sustained bruising to the left of his chest.

The 62nd National Attorney and 81st District Attorney of the Metropolitan Area of Caracas were commissioned to investigate this case.

The 3rd State Attorney of Carabobo was commissioned to investigate this case.

+ 4 May 2017

A 38-year-old officer with the San Joaquin Municipality, Carabobo state.

On 3 May 2017, he was on duty a demonstration and trying to prevent people from disrupting businesses in the area, when several men shot at him, wounding him in the right thigh. He was taken to the Central Hospital in Maracay, Aragua state, where he underwent surgery but died on the following day.

Carabobo

The 61st National Attorney and 5th State Attorney of Carabobo were commissioned to investigate this case.

36 Hecder Vladimir Lugo Pérez

4 May 2017

He was 20-years-old and a keen swimmer. He had obtained his high school diploma, and was sitting entrance exams for university.

Carabobo

On 4 May 2017, he was in Don Julio Centeno Avenue, next to the residential complex Los Tulipanes in San Diego, Carabobo state, when he was hit in the head by a bullet.

The 34th National Attorney and 28th State Attorney of Carabobo were commissioned to investigate this case.

+ 8 May 2017

He was 31 years old and worked as motorcycle taxi rider.

On 8 May 2017, he was on a demonstration at the junction between 26th street and Campo Elias, Merida state, when a bullet hit him in the head.

Mérida

The 38th National Attorney and 4th State Attorney of Merida were commissioned to investigate this case.

38 Miguel Fernando Castillo Bracho

+ 11 May 2017

He was a 27-year-old communications and audiovisual student at the Santa Maria University (Universidad Santa Maria Santa).

Caracas

On 11 May 2017, he was shot in the chest as he was walking along the Main Avenue of Las Mercedes in the Baruta Municipality, Caracas.

The 34th National Attorney and 126th District Attorney of the Metropolitan Area of Caracas were commissioned to investigate this case.

39 Luis José Alviarez Chacón

+ 15 May 2017 Táchira

He was 18 years old and only child. He had a high school diploma and was a keen ping-pongplayer.

On 15 May 2017, he was taking part in a demonstration in the Palmira Parish of the Guásimos Municipality, Táchira state, when he was shot in the chest. He was taken to the Fundahosta Hospital. Two officers with the Bolivarian National Police were detained in connection with the case.

The 85th National Attorney and 20th State Attorney of Tachira were commissioned to investigate this case.

+ 16 May 2017

A 32-year-old graduate in administrationstudies, accounting and finance who worked as motorcycle taxi rider. He was well where he lived forcommunity work, includinghelping to distribute food.

On 16 May 2017, he was on a demonstration, across Bolivar Square, Capacho Nuevo Municipality, Táchira state, when he was shot in the chest. At the time of writing, a Táchira state police officer, Luis Oviedo Avila, was detained for this in connection with the shooting.

The 85th National Attorney and 20th State Attorney of Táchira were commissioned to investigate this case.

41 Yeison Nathanael Mora Castillo

+ 16 May 2017

He was 17 year-old and worked in a hardware store.

On 15 May 2017, he was on a demonstration in Ciudad Bolivia Parish, Pedraza Municipality Barinas state, when several people started shooting. He was hit in the right eye. He was taken to the Luis Razetti Hospital and underwent, surgery but died on the following day.

42 Diego Fernando Arellano De Figueredo

+ 16 May 2017

He was 31 years old and worked as a biologist.

On 16 May 2017, he was on Perimetral Avenue, at the entrance to the Los Castores Residential Complex, San Antonio de Los Altos, Los Salias Municipality Miranda state, when he was shot in the chest. He was transferred to the El Retiro medical centre, where he died.

The 62nd National Attorney and 24th State Attorney of Miranda were commissioned to investigate this case.

+ 17 May 2017

He was 15 years old and worked in construction. He had six brothers.

On 16 May 2017, he was in a market in Sabaneta, La Concordia Parish in San Cristobal, Táchira state, where a demonstration was taking place. He was shot in the left lower abdomen. He was taken to the medical San Cristobal Dr. Jose Maria Vargas Central Hospital, where he died the following day.

44 Manuel Felipe Castellanos Molina

+ 17 May 2017

He was 48-year-old sales assistant and was married with three children.

On 17 May 2017, he was in a market in Tucapé, Cardenas municipality, Táchira state, where a barricade had been erected and a demonstration was taking place. Police officers dtried to disperse the demonstration by firing live ammunition. One bullet hit him in the neck (left cervical sternocleidomastoid). Three officers with the Bolivarian National Guard were detained in connection with the case this case.

The 85th National Attorney and 20th State Attorney of Tachira were commissioned to investigate this case.

45 Paúl René Moreno Camacho

+ 18 May 2017

A 24-year-old medical student at Zulia University of Zulia (Universidad del Zulia) he worked as a paramedic and was member of a group of volunteers who provide humanitarian and first aid assistance.

Zulia

On 18 May 2017, he was on a demonstration in Fuerzas Armadas Avenue in Maracaibo, Zulia state, when a woman drove her car over a barricade and hit him and then drove off, Paúl René Moreno Camacho was transferred to the Adolfo Pons Hospital, where he died.

The 4th State Attorney of Zulia was commissioned to investigate this case. Two people were detained in connection with the case.















46 Daniel Rodríguez Quevedo

+ 18 May 2017 Táchira

He was 18 years old and had just begun his law studies at the Táchira Catholic University (Universidad Católica del Táchira.

On 18 May 2017, he was in the Venecia neighbourhood on Santa Ana main avenue, Córdoba municipality in Táchira state, mending the drains with his neighbours, when several people on motorcycles and carrying guns fired several times, hitting him in the head. He was immediately transferred to the Central Hospital, where he died.

The National 22° and Táchira 4° public prosecutors were commissioned to investigate this case.

47 Jorge David Escandón Chiquito

+ 19 May 2017 Carabobo

He was 37-year-old graduate studying for a masters inlabour relations and human resources at the University of Carabobo (Universidad de Carabobo).
